This schedule is for the move-in of your exhibit and display at this time. You are not required to set your display at this time.

No trucks will be checked in for unloading after 2:00 p.m. daily.

Deliveries arriving off-target (not meeting assigned target date and time) will be unloaded after all on-target vehicles have been unloaded and could incur overtime penalties.

If you are unable to meet your assigned target date and wish to change for any reason, you must make prior arrangements.

No target date will be changed without approval from Freeman.

Written requests are required and will be acknowledged in writing. Please include booth number, dimensions and weight of heaviest piece, total number of pieces or number of trailers, as well as delivery time requested.

* Any freight received in the Freeman Advance Warehouse will be delivered to your booth prior to your confirmed targeted move-in.
